- 1. City Engineer Cates would like to go out for bid for the repainting of the water tower. He also received the logo from Alderman Schoenfeld and will have that also included in the bid. Terris would like to open the bids on March 24, 2023, so would need to have it published in the paper. Alderman Koepke made a motion for City Engineer Cates to go out for Bid and have City Clerk Smythe post in the paper in regards to bids for the repainting of the water tower. Alderman Schoenfeld seconded the motion. All Alderman voted "aye". Motion carried.
- 2. City Engineer Cates did discuss having the permit limits raised in regards to the wastewater treatment.
- 3. City Engineer Cates brought an updated zoning map for the Alderman to review and look to see what would need to be changed/added.

### Nick Grube, Public Works Director -

The GAA would like to build a retaining wall Southwest by the maintenance shed, they are
asking if the city would haul rock. The GAA does have some specs, wanted to update the
city of plans. Inspector Pilgram stated that the retaining wall would need to be 5ft or less.
Public Works Director Grube said he would let the GAA know the requirement for the
height of the wall

### James Birmingham, Police Corporal

- Corporal Birmingham asked the board if the Police Department could enter into an agreement with MODOT for a Safety Grant. Alderman Koepke made a motion for the police department to enter into an agreement with MODOT for a Safety Grant. Alderman Schoenfeld seconded the motion. All Alderman voted "aye". Motion carried.
- 2. Corporal Birmingham asked the board if the Police Department could enter an agreement with Purple Wave to sell the Charge that was the previous patrol car that is not being used. Alderman Koepke made a motion for the Police Department to enter an agreement with Purple Wave to sell the Charger that is no longer being used. Alderman Novotney seconded the motion. All Alderman voted "aye". Motion carried.

# Shelley Smythe, City Clerk

- 1. City Clerk Smythe talked to the Board about various grants that are available through Polaris. City Clerk Smythe asked if she could try and get a grant for the police department to possibly get a Polaris side by side that would be beneficial for events within the city and for when the trail would be done. Alderman Koepke made a motion to have City Clerk Smythe apply for grants in regards to getting a side by side for the police department. Alderman Novotney second the motion. All Alderman voted "aye". Motion carried.
- 2. City Clerk Smythe talked to the Board in regards to the upgrade of Sequoyah Water System and the Online Payments. Sequoyah will be updated to allow the citizens be able to have their utility bills emailed, and can view usage online. Will be able to set up for auto bill pay. City Clerk Smythe stated there is no extra cost for this upgrade through Lockbox and the upgrade to Sequoyah will only be \$50/month.
- 3. City Clerk Smythe asked the Board if they could donate the Legion Hall for the Library to have a Paint and Sip to raise money to help with the damages that occurred when the pipe burst within the library, filling it with water. Alderman Koepke made a motion to donate the Legion Hall to the library to raise money for damages that occurred during a pipe burst. Alderman Schoenfeld seconded the motion. All Alderman voted "aye". Motion carried.
