1. Issued two new permits for two new homes of 1500 sq feet each.

- 1. Discussed we are going out to Bid on the Water Tower repaint, all bids to be received withing City Engineers office on March 24, Nick will meet Terris at his office and they will go over bids.
- 2. Discussed the Zoning Map, it is finished and there will be a shiny new one that will be supplied to the city and we will also have a link on our website for anyone to be able to review.

Nick Grube, Public Works Director

- 1. Would like to start going out for bid on asphalt, chip/seal and concrete. Alderman Via made a motion for Public Works Director Grube to start going out for bid of asphalt, chip/seal and concrete for streets for 2023. Alderman Koepke seconded the motion. All Aldermen voted "aye". Motion Carried.
- 2. Informed the Board that the air blower for the waste water treatment plant is not working, and the spare that he had is what he replaced it with. This now leaves him without a spare. Would like the board to approve for him purchase a new one. Alderman Koepke made a motion for Public Works Director to purchase a new air blower for the waste water treatment plant to have as a spare, but not to exceed \$5500.00. Alderman Novotney seconded motion. All Aldermen voted "aye". Motion Carried.
- 3. Director Grube let the Board know that the engine in the international tantum dump truck will need to be overhauled or replaced. When he was hauling rock, the engine quit. This engine has already been rebuilt 2 years prior to this. For this engine to be rebuilt it would cost \$10,000. Alderman Koepke made a motion for Public Works Director Grube to go out and get prices of another engine to replace the one that is in the truck now. Alderman Novotney seconded motion. All Aldermen voted "aye". Motion Carried.
