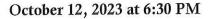


REGULAR BOARD MINUTES

DEPARTMENT REPORTS

Phil Pilgram, City Inspector- Discussed progress with new Dollar General. New houses under construction are looking good.

Terris Cates, City Engineer- Discussed Small Water Tower progress. Change order on the smaller tower, for \$1650.

Discussed Conservation Grant for the splash pad, this is a 50% match so the city would have to have \$175,000 to match the grant. Will need motion made to have Mayor sign Conservation Grant. There is a 2-year window, this will allow the city to be able to come up with the funds. A resolution will need to be drawn up to authorize the filing of the application with the MO Department of Natural Resources, Division of State Parks.

Mayor Koepke explained she wants to set goals for the next two years and try and get some of the funds. Terris explained that the deadline for the grant application is November 16, so would need a motion made prior. Discussed tabling the motion until next meeting. All Aldermen agreed. Motion tabled.

Tabling the motion, until the next meeting and see what we can get from the citizens/businesses.

Nick Grube-City Administrator-Discussed the GIS for the lead service line inventory. Discussed the small water tower being finished. Discussed progress on To-Do list from Mayor.

Jim Helton, Police Chief - Thanked Jennifer Griffith for the donations of the 2 Guardian Angel lights.

Mayor Koepke recommended Cary Parker to be selected to fill Ward II vacant seat. Alderman Novotney motioned to accept the appointment of Cary Parker as Alderman for Ward II seat. Alderman Guerrant seconded the motion. All Aldermen voted "aye". Motion carried.

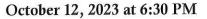
City Clerk Smythe swore in Cary Parker to Alderman Ward II.

MAYOR REPORTS

Mayor Angela Koepke- Discussed progress on the spillway at the lake at City Park. Discussed the dump truck and progress. Discussed the town clean up and stated there were no City dollars being spent. Thanked the police for doing a great job keeping citizens on the right track and cleaning up. Discussed progress with the Board of Adjustments. Addressed a concern from a citizen about gambling machines, stated they are not against ordinance. Addressed a concern from a citizen about a mobile home clean up, is waiting on a response from the attorney. Would like to have a meeting with the City Administrator to plan and make goals, to set goals for the next two years and try and get some of the funds before applying for a grant for the splash pad. Stated that the Chamber of Commerce would like watering cans to put in the back of a truck to water flower around town when spring comes again. Stated that the Chamber of Commerce would like a glass display case established at City Hall to advertise events.

After discussion amongst the Board, all aldermen decided to not accept the establishment of a display case at City Hall.
